in multiple languages, played a vital role in promoting fair and equal participation and $e_{c_{i_{a_{r_{a}}}}}$ collaboration among everyone involved. Furthermore, this study analyzed language policies within the framework of global matters, highlighting the importance of policies that prioritize inclusivity, adaptability, and the provision of resources for translation services. These policies were successful in promoting communication and collaboration among communities that speak different languages.

The existence of different languages in the field of diplomacy presented specific difficulties. These challenges consisted of delays in negotiations and a lack of coordination among the parties involved. Nevertheless, the effective resolution of these challenges has been achieved through the application of strategic language management, cultural awareness, and the strategic utilization of language resources.

This study suggests that the impact of linguistic diversity on addressing global problems is intricate and has many aspects. The effectiveness of language policies and strategic language management plays a crucial role in influencing outcomes. To find a middle ground between the difficulties and advantages presented by the variety of languages, a thorough approach is necessary.

Recommendations

- 1. Design inclusive language training programs for diplomats, policymakers, and personnel of international organizations with the aim of enhancing their language proficiency and fostering effective intercultural communication abilities.
- 2. To enhance the effectiveness of global issue resolution efforts, it is advisable to allocate resources towards the development and implementation of sophisticated translation and interpretation technologies. These technologies would enable seamless and immediate multilingual communication in real-time.
- 3. Develop and execute language policies that give importance to inclusivity and fairness, considering the wide range of languages present in global issue contexts.
- 4. To facilitate the active participation and contribution of all stakeholders, it is essential to designate resources for translation services, interpreters, and the creation of multilingual documents.
- 5. Create specialized teams for multilingual diplomacy consisting of individuals who are skilled in the necessary languages and possess a deep understanding of cultural subtleties.
- 6. Advocate for the implementation of cultural sensitivity training programs for diplomats in order to foster trust and collaboration among stakeholders with varying linguistic backgrounds.
